TRANSHEX HOUSING DEVELOPMENT NAMING OF STREETS

Breede Valley Municipality invites the community members of Breede Valley to submit proposals for street names for the Transhex Development. The Transhex Development have 168 streets to be named. The naming of the streets should be in line with the guidelines listed below.

GUIDELINES FOR THE SELECTION OF NAMES:

- i. There shall be no duplication of names or confusingly similar names in the BVM;
- ii. Names of which the spelling or pronunciation may cause confusion because of its correlation with existing names, should be avoided
- iii. Names shall not be too long. Street names shall be limited to a length of 18 characters, including any combination of spaces, letters or punctuation in the base portion of the name, to facilitate the use of standard signage materials. Only in exceptional circumstances will street names of a longer length be considered with the required justification;
- iv. Names shall not be discriminatory or derogatory from the point of view of race, religion, sex, colour, creed, political affiliation or other social factors to any community or section of a community;
- v. Names shall promote goodwill and reconciliation;
- vi. Names may be expressed in any of the three official languages of the Province;
- vii. Names shall promote a sense of ownership and the character of an area.
- viii. Names that could be construed as advertising a business, service or product shall not be allowed;

Proposals must be submitted on or before the 28th of June 2019. A box will be placed at Breede Valley Municipality (Main Building) for reception of proposals. It can also be emailed to nsodladla@bvm.gov.za

TRANSHEX BEHUISINGSONTWIKKELING BENAMING VAN STRATE

Die Breedevally Munisipaliteit nooi gemeenskapslede van die Breedevally uit om voorstelle vir straatname vir die Transhex-behuisingsontwikkeling voor te lê. Die Transhex-ontwikkeling het 168 strate wat name moet kry. Die benaming van die strate moet aan die onderstaande riglyne voldoen.

RIGLYNE VIR DIE KEURING VAN NAME

- i. Daar mag geen duplisering van name of verwarrende soortgelyke name in die BVM-area wees nie.
- ii. Name waarvan die spelling of uitspraak verwarring kan veroorsaak weens die verband met bestaande name, moet vermy word
- iii. Name moet nie te lank wees nie. Straatname sal beperk word tot 'n lengte van 18 karakters, insluitend enige kombinasie van spasies, letters of leestekens in die basisgedeelte van die naam, om die gebruik van standaard kenteken-materiaal te fasiliteer. Slegs in buitengewone omstandighede sal straatname met 'n langer lengte oorweeg word met die vereiste regverdiging;
- iv. Name moet nie diskriminerend of afstootlik in terme van ras, godsdiens, geslag, kleur, herkoms, politieke affiliasie of enige sosiale faktore ten opsigte van enige gemeenskappe of gedeeltes van gemeenskappe wees nie.
- v. Name moet welwillendheid en versoening bevorder;
- vi. Name kan uitgedruk word in enige van die drie amptelike tale van die Provinsie;
- vii. Name moet 'n gevoel van eienaarskap en die karakter van 'n area bevorder.
- viii. Name wat geag kan word dat dit 'n besigheid, diens of produk adverteer, sal nie toegelaat word nie.

Voorstelle moet ingedien word voor of op 28 Junie 2019. 'n Houer sal by die Breedevally Munisipaliteit (Hoofgebou) geplaas word vir die ontvangs van voorstelle. Dit kan ook per e-pos aan nsodladla@bvm.gov.za gestuur word.

- iii. Amagama awazubamade kakhulu. Amagama ezitalato azakuba bubuncikane beleta eziyi 18, kuqukwa nezikhewu, iileta, iziphumlisi, isiseko segama, ukulungiselela izixhobo ekuzakubhalwa kuzo. Zimeko ezizodwa kuphela apho ubude buya kuqwalaselwa kwenziwe okufanelekileyo;
- iv. Amagama akayi kuba nocalucalulo okanye ukuthoba isidima ngokujongwa kohlanga, inkolo, isini, umbala, inkolelo, ukusebenzisana kwezopolitiko okanye ezinye izinto zentlalo okanye icandelo loluntu;
- v. Amagama aya kukhuthaza ukulungiswa noxolelwaniso;
- vi. Amagama angachongwa ngazo naziphi na iilwimi ezintathu ezisemthethweni zePhondo;
- vii. Amagama aya kukhuthaza ubumnini kunye nobume bendawo;
- viii. Amagama anokubonwa enenjongo yokuthengisa ishishini, inkonzo okanye izinto ezithengiswayo akavumelekanga.
